Purchaser Agrees

Purchaser agrees to provide Simplex Transportation Department with complete, accurate directions prior to submitting the Delivery Confirmation Form. In the event there are no directions prior to the confirmation, Simplex Transportation Department will not agree to accept this delivery confirmation. The confirmation is not considered accepted until an authorized person from Simplex Transportation Department signs and returns a completed confirmation form to you.

Permits will be ordered (10) calendar days prior to the confirmed shipping date.

Purchaser must notify Simplex Transportation Department in writing of any changes within (10) full calendar days prior to the above agreed upon date in order to prevent being charged any permit or cancellation fees.

Upon failure to take delivery on the above Purchaser's confirmed delivery date, the following costs will be incurred:

- All permit fees
A delivery cancellation charge of \$250.00 per carrier
Storage fees from the fourteenth calendar day beyond the off line date of the production schedule

In the event that the delivery is canceled by the Purchaser and a driver shuttle had been previously requested and scheduled, Simplex cannot guarantee the availability of a shuttle driver for the rescheduled delivery due to previous delivery commitments.

NOTE: SAME DAY SETS ARE NOT RECOMMENDED AND ARE HIGHLY DISCOURAGED BY SIMPLEX. PURCHASER ASSUMES ALL RISKS AND EXPENSES WHEN DOING SAME DAY SETS - NO EXCEPTIONS.

- You or your company representative must meet our driver at a pre-determined location to direct him to the building site for the Purchaser acceptance and payment of home. Independent escort car fees are to be paid to each independent escort car driver. (Note: Any layover expenses incurred by independent escorts must be paid at this time.) Independent escort drivers are not employees of Simplex Industries.
SIMPLEX INDUSTRIES, INC. intended delivery is to the curb.
When the Unit or Units leave the main road, or the delivery is impeded by unsafe or un-passable conditions, any further transportation costs (such as tow charges, etc.) are the responsibility of the Purchaser. Please note: Simplex will not take responsibility for delivery on a non-paved road area or unsafe delivery conditions. Be prepared with proper on-site equipment, which may be necessary to pull the Units onto the construction site.

NOTE: Simplex reserves the right to stop delivery and receive a liability waiver and/or house payment from the Purchaser if Driver determines home site access to be impassable, impaired, improper, unstable or unsafe. It is the responsibility of the Purchaser to provide a safe access way to the job site. When the access way is determined to be unsafe, Purchaser agrees to make immediate payment. Simplex reserves the right to demand immediate payment before considering to continue the delivery. In the event that access as planned by the Purchaser is too dangerous to proceed, The Purchaser will arrange for disposition or storage of the Units and shall pay the driver the full invoice amount as if the Units had been delivered to the job site. Any additional costs incurred or caused by delays shall be paid by the Purchaser.
